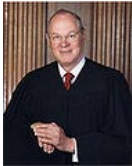

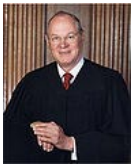


JUSTICE KENNEDY

JUSTICE SCALIA attaches a note citing a study contending that 98% of Americans eat turkey on Thanksgiving



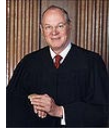
JUSTICE KENNEDY

Listen Sam, you will obey me, I am your Commander and Chief.



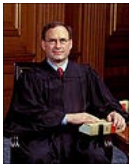

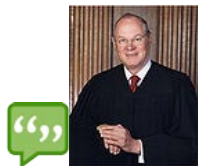


JUSTICE KENNEDY posted a comment on your wall

JUSTICE KENNEDY posted a comment on your wall

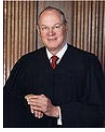

Clarence, you ask too many damn questions.



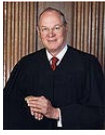
JUSTICE GINSBURG
